# SAGE RELEASES THE FAS 2009.1 UPDATE

Sage recently released an update for Sage FAS Fixed Assets. The FAS 2009.1 Update is now available for download at [www.sagefas.com/update](http://www.sagefas.com/update) and includes changes that accommodate new tax limits, revised forms, and 2 pieces of legislation passed in 2008. In addition, the FAS 2009.1 Update includes a couple of new features that we'll quickly explore.

## New Legislation

The 2009.1 Tax Update incorporates provisions for the new **Emergency Economic Stabilization Act of 2008** and the **Heartland, Habitat, Harvest, and Horticulture Act of 2008**, which allows a 168k bonus and section 179 expensing.

## New Limits

The Sage FAS 2009.1 Update also accommodates new tax limits including scheduled updates to the Section 179 deduction, new tax credits for historic properties and green energy expenditures, updated Section 179 limits for qualified disaster zones, and updated form 4562 worksheets and other updated tax forms.

## New Features

In addition to the boring old tax stuff, you also benefit from a couple of useful new features including:

**Assets Snapshot** - provides an 'at-a-glance' graphical summary of your most important fixed asset information.

**Expanded FAS Report Writer Capabilities** - FAS Report Writer is now powered by Crystal Reports® XI which offers even more flexibility for creating custom reports. Crystal Reports XI offers features like run-time input parameters, a formula workshop, support for multiple data sources in a single report, charts and graphs, and much more. Simply put, the FAS reports just got a LOT better!

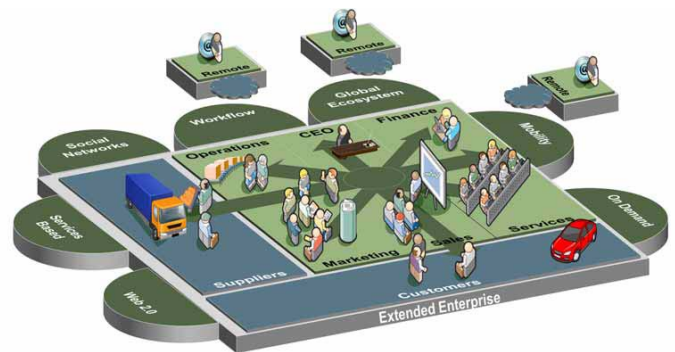
