## A Sneak Peek at Version 4.4

In November, Sage published a pre-release guide for Sage MAS 90 and 200 Version 4.4 that provides us with a sneak peek of the new features and enhancements. Let's take a closer look at Version 4.4 which is scheduled for release during the 1st quarter of next year.

### Expanding the Business Framework™

The power of the Business Framework will be incorporated into Inventory Management, Purchase Order, Bill of Materials, and Bar Code. Originally introduced into the core modules (GL, AP, etc.) several versions ago, Business Framework enables features like dual grid entry, drag-and-drop personalization of screens and workflow, electronic Memo Manager, and extensive hyperlinks and right-click capability to reduce keystrokes and streamline transaction processing.

### Better Inventory Management ... and More!

Version 4.4 introduces extensive new features for inventory control and related modules like Purchase Order, Bill of Material, and Bar Code. Starting with **Inventory Management**, you'll benefit from a streamlined physical count process, increased decimal precision, and flexible standard cost adjustments. In **Purchase Order**, new batch entry features will allow more than one user to enter purchase transactions at the same time. Plus, enhancements to the Material Requisition process, flexible label printing options, and improved reports will streamline purchasing tasks. The **Bar Code** module has been improved to process much larger amounts of data at greater speed and reliability. Finally, **Bill of Materials** includes new views and inquiries to see Single Level, Indented, or Summarized data in a list format with the ability to resize and sort.

### Parallel Migration

Parallel Migration will provide the ability to migrate from previous versions of Sage MAS 90 or 200 (including version 3.71, 4.0, 4.05, 4.10, 4.2, or 4.3) to Version 4.4 with more freedom and control over the upgrade process. You can begin your upgrade by installing Version 4.4 in a separate (parallel) location on the same server (or on a different server) while you continue normal business operations on your current version.

### Other Features and Usability Enhancements

**New Information Center** - from your business desktop, you can access the community forums, blogs, and other useful information posted on the Sage MAS 90 and 200 [Online Community](#).

**"Tell Us What You Think"** - submit enhancement requests directly from your business desktop.

**Extended Customer and Item Numbers** - the Customer Number field will be expanded to 20 characters and the Item Number field expanded to 30 characters.

## 5 Tips for a Successful Year End

**1. Back Up Your Data** - The first thing you should do before beginning *any* year end processing task is to execute a complete back up of your Sage MAS 90 or MAS 200 data. You should also **test the back up** to ensure it was successful and the data is readable. Without a reliable back up, there is no way to restore your system to its original state should you need to undo a significant year end processing mistake. It's also a good idea to make another back up **after** you successfully complete the year end close.

**2. Payroll Planning** - Since year end Payroll is typically a significant undertaking, it's a good idea to **begin reconciling** all of your payroll tax reports to the general ledger **in early December**. This gives you a chance to catch errors early and avoid filing an amended payroll tax return.

**3. Download Tax Table Updates** - Download and install any necessary tax table updates for your Sage MAS 90/200 system. Tax table updates are available at the Sage [online support center](#).

**Important Note:** do not install tax table updates until **after** you run W-2 forms and **before** the first payroll of the new year.

**4. Review Module Options** - Each module is a little different with respect to year end processing. Also, data may or may not be cleared out based on your system's set up options. It's a good idea to review module closing options and follow a module-by-module checklist of year end processing tasks to ensure that everything is performed in the proper sequence.

**5. Gather Information Early** - Minimize the last minute scramble and stress of meeting deadlines by gathering important information **before** the end of the year. This can include information from vendors, employee address updates, and other changes that may have occurred during the year.

1. Bill of Materials
2. Work Order Processing
3. Bar Code
4. Purchase Order Processing
5. Sales Order Processing
6. Inventory Management
7. Material Requirements Planning
8. Timecard
9. Electronic Reporting/Magnetic Data
10. Payroll (*Quarter-end processing*)
11. Accounts Receivable
12. Accounts Payable
13. Job Cost
14. General Ledger

Likewise, salespeople benefit from access to pricing, inventory, and customer history without having to fumble around in MAS 90 or interrupt your accounting staff with numerous inquiries.

Integrated data translates into more accurate reports, better decisions, and a complete 360-degree view of your operations.
